**Bitch Requirements:**

- 1- Copy of AKC registration certificate, proof of full registration.
- 2- Color photo of bitch- if shipping semen.
- 3- Passing OFA Hip (Excellent, Good, or Fair) or PennHIP evaluation (no greater than .4 DI and no DJD).
- 4- OFA Elbow Normal score.
- 5- Current CAER eye certification of clear or with breeder options at stud owner's discretion.
- 6- EIC testing completed.
- 7- CNM testing completed.
- 8- Must not carry or express the dilute (d) gene. Testing may be requested before approval.

**Bitch Owner Responsibilities:**

Bitch owner will be responsible for all costs incurred to complete the breeding, including, but not limited to: transport fees for bitch, AI supplies, AI procedures, semen shipping fees and supplies, hormone testing of bitch, and vet care required for breeding. All semen preparation and shipping container rental fees will be owed to Auburn University Veterinary Clinic and paid before semen is released by the clinic. Shipping fees will be owed to shipper, FedEx or UPS.

It is required that progesterone testing be completed for the female to determine optimal breeding time for frozen semen breeding. It is strongly recommended that an experienced and proficient reproductive vet be used for frozen semen breedings to help determine optimal breeding timing and perform the AI. It is also the responsibility of the bitch owner to convey to the stud owner and/or reproductive vets used, when the bitch begins her heat and results of all hormone testing completed. It is the responsibility of the bitch owner to ensure the stud owner knows when semen needs to be shipped. It is the responsibility of the bitch owner to ensure the bitch has not been bred prior to this breeding, and ensuring she is not bred after stud service is provided by this stud.

**Stud Service:**

Stud fee of \$800 is due before semen is shipped or released to bitch owner. Stud owner is not obligated to the sign litter registration application without full payment of stud fee and shipping fees. No guarantee of live births can be offered.

Frozen semen is stored at Auburn University Veterinary Clinic in Auburn, AL. The clinic's phone number is (334) 844-4690.
